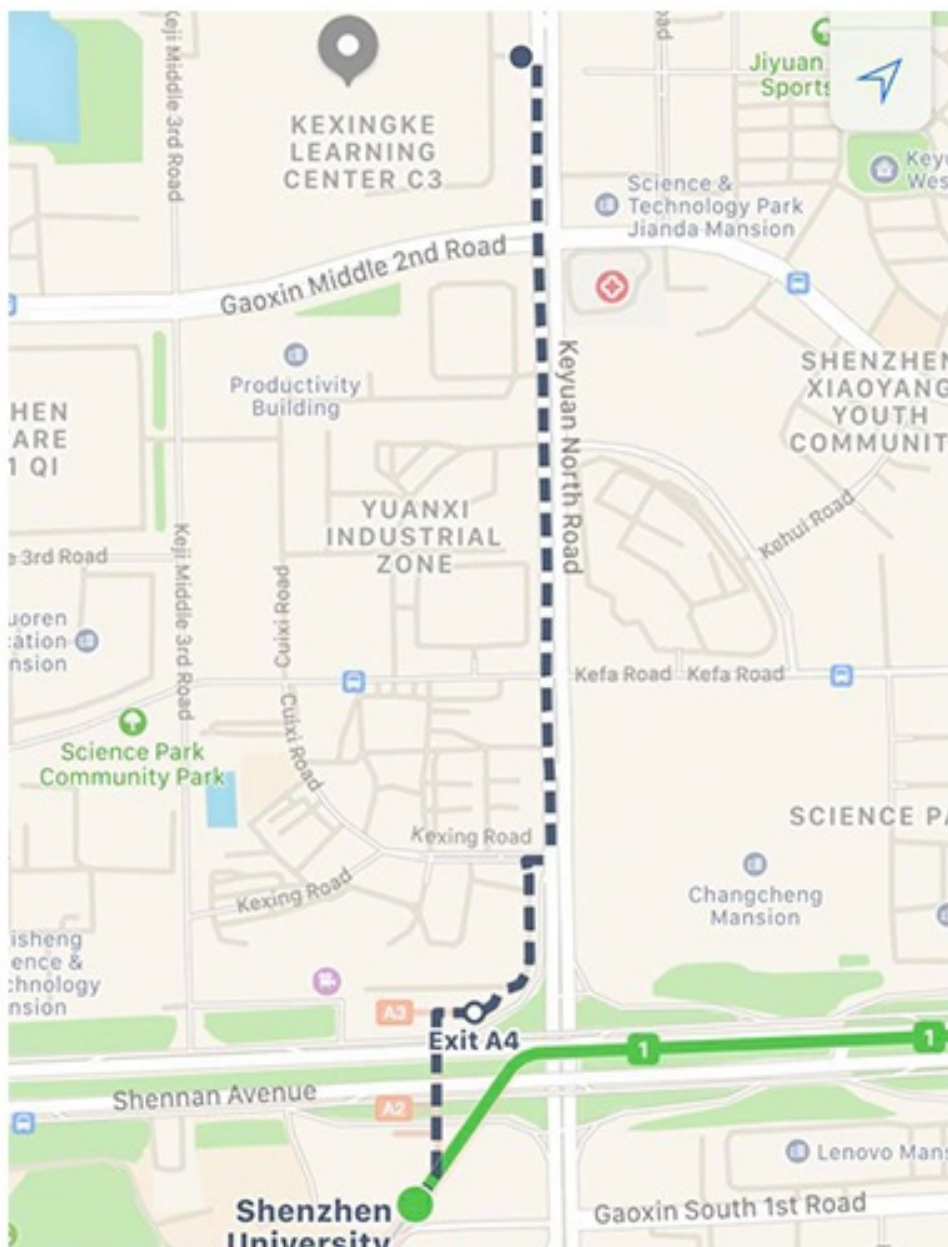


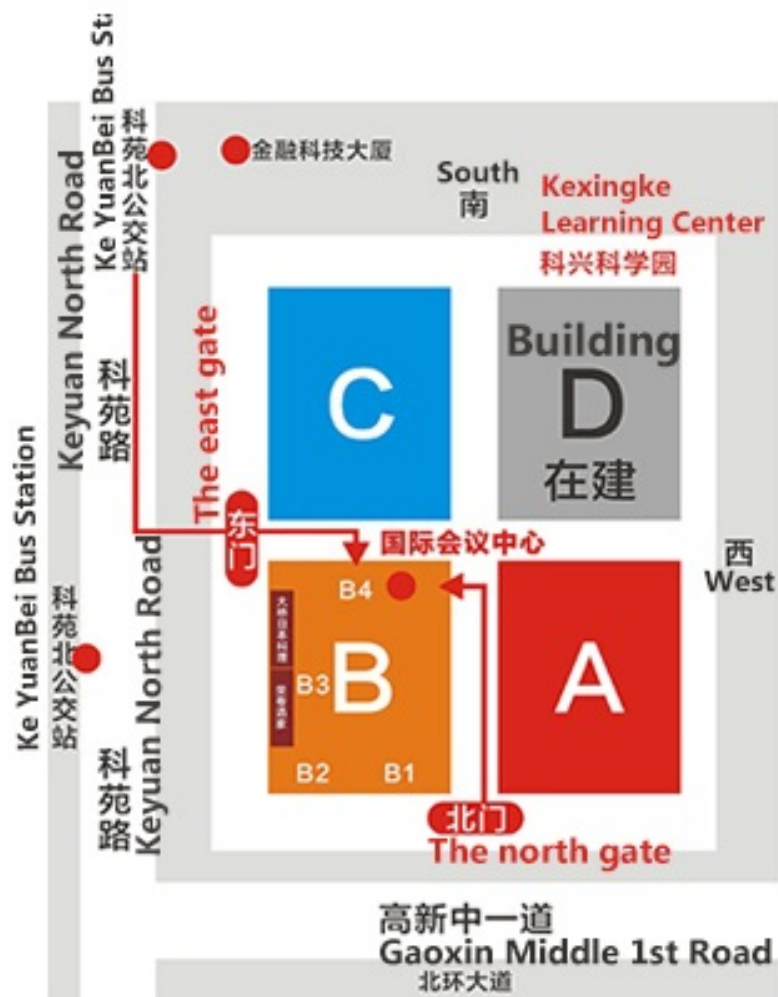


## The metro guide to Kexingke learning center 坐地铁到会场指南
